Information on the acquisition of Kremer GmbH by ERIKS

Dear Sir or Madam,

We would like to officially inform you that ERIKS has taken over the business activities of **Kremer GmbH** with effect from 15 December 2025. As part of the takeover, **Kremer Technology GmbH**, a company of the ERIKS Group, will continue the business activities of Kremer GmbH. The takeover also includes existing contracts and (individual) orders with you (please note: if these date from before 15 December 2025, but only if they do not constitute claims that must be registered in the insolvency table in accordance with Section 38 of the Insolvency Act (InsO) and if they have been entered into with the consent of the (provisional) insolvency administrator). The insolvency administrator of Kremer GmbH has already approved the takeover.

We have summarized the resulting changes to the master data for you in **the appendix**. We kindly ask you to make the appropriate adjustments. The following applies to you:

- Deliveries **made** by you **before 15 December 2025** will continue to be made to KREMER GmbH. KREMER GmbH will therefore remain the invoice recipient for the deliveries and services concerned.
- Deliveries **made** by you **from 15 December 2025** onwards will be made to Kremer Technology GmbH. The resulting claims will be paid by the latter. We kindly ask you to send the corresponding invoices to the billing address shown in the appendix.
